

General conditions of 2QT Cosmetics Club Membership

2QT Cosmetics Club was founded and is represented by company DREAM COSMETICS SRLS, based in via dell'Arcoveggio nr 49/5, CAP. 40121 Bologna, Italia. Identification CCIAA Bologna No and VAT Reg No: 02892630308, REA: BO - 536358, registered in the Commercial Register at the Regional Court of Bologna.

1. A Business Partner/Member can be a natural person whose age is over 18 years old, a legal entity, or an organizational entity with legal capacity.
2. 2QT Cosmetics Club Membership comes into existence in the moment of completion of ON-LINE registration on the official 2QT Cosmetics website (www.2qtworld.com) and once Business Partner has a nickname identity as username in 2QT Cosmetics Club.
3. After successful ON-LINE registration, Business Partner receives a confirmation of his membership on his email which was used for registration. Business Partner must confirm the registration email in order to become an active member. These data are necessary for log in to member section of 2QT Cosmetics official website. Member commits himself to enter during registration all required identification and contact data and also commits himself to update in case of change any of these data in tab My Account – Edit Profile – Personal Information. 2QT Cosmetics does not carry any responsibility for Business partner's incorrect contact data in the 2QT Cosmetics registers and following incorrect deliveries within official communication between 2QT Cosmetics and Business partner.
4. 2QT Cosmetics does not carry any responsibility for a damage caused when Business partner gives away his personal login information to a 3rd party.
5. Member can hold only one member ID. In case of finding out of existence of repetitive registration even in a hidden way, only the first registration will be considered as valid and all the following registrations will be cancelled. In case of finding out that a Member made repetitive registrations for reasons that misleads or violates 2QT Cosmetics Club Membership's rules, or damages 2QT Cosmetics and 2QT Cosmetics members, 2QT Cosmetics has the right to cancel the 2QT Cosmetics Club Membership to the Member.
6. Member has the right to order - purchase 2QT Cosmetics products for member prices, to perform direct sales of 2QT Cosmetics products under his name and on his account as a separate business subject and to provide promotion services in favor of trademark 2QT Cosmetics (to sponsor – to register new members into 2QT Cosmetics). In such case, Member is obliged to abide related laws and regulations in the country of his activity and to submit stipulated tax return and other overviews. If a claim for commission payment based on 2QT Cosmetics Marketing Plan comes into existence to Business partner, the payment is governed by the Conditions for commission payments to Business Partner of 2QT Cosmetics Club effective in his country. Business Partner is not a 2QT Cosmetics sales representative or its employee or an employee of 2QT Cosmetics. Member is responsible in front of the government of the country where he operates for following the laws and paying taxes as the regulation of the country requires. 2QT Cosmetics does not carry any responsibility neither for Member's violations of the laws and regulations in the country of activity 2QT Cosmetics nor for non-submitting or non-payment of relevant taxes and contributions nor for non-fulfilment of other obligations towards the country arising from his business activity.
7. Business Partner receives points for orders - purchases of 2QT Cosmetics products which are awarded by points. A list of products awarded by points together with numbers of points assigned to 2QT Cosmetics products is available on the official website. According to the official 2QT Cosmetics Marketing Plan the points that Business Partner reaches in a decisive period (one solar month according to the official calendar in Italy) correspond to a qualification, and to each qualification corresponds monthly commissions. Business Partner must reach 30 personal points monthly in order to have the right to his monthly commissions.
8. Business Partner is obliged to collect or take his deliveries of the 2QT Cosmetics products ordered within collection time and to pay for it. In case of repetitive problems with delivery of ordered products and if the delivery is not collected, Business Partner must reimburse any expenses related to the delivery to 2QT Cosmetics. Repetitive problems related to unsuccessful delivery is considered as a repetitive violation of the General conditions of 2QT Cosmetics Club Membership. 2QT Cosmetics has the right to refuse processing orders of such member who acted as mentioned above, and also has the right to deduct the expenses related to the delivery from Business Partner's commission. In case of inability to deduct the expenses

related to the delivery from Business Partner's commission, 2QT Cosmetics has the right to process the next order of this member only after reimbursement of the expenses.

9. Business Partner engaged in sale of 2QT Cosmetics products can present and offer these products personally in form of direct selling or on the markets, craft fairs, festivals and other similar events but only exclusively for a promotion and sponsoring purposes – registration of new Business partner into 2QT Cosmetics Club. Sales through its own store with fixed sale prices is not forbidden but is subject to an approval from the 2QT Cosmetics marketing department.

10. In case of Business Partner's business activity in connection with cooperation with 2QT Cosmetics, the company 2QT Cosmetics does not carry any responsibility neither for non-acquiring necessary permits for business activity nor for non-submitting or non-payment of relevant taxes and contributions nor for non-fulfilment of other obligations towards the country arising from his business activity.

11. Business Partner is obliged to provide to costumers, interested parties in 2QT Cosmetics Club Membership and other members only true information about prices, characteristics and availability of products from 2QT Cosmetics offer in a way which is clear and identical to informations from current informative and advertising materials published by 2QT Cosmetics with regard to fact that 2QT Cosmetics products are original products properly registered and certified for given market. Member cannot by no means mislead the interested parties in the 2QT Cosmetics products or in the cooperation with 2QT Cosmetics by comparing 2QT Cosmetics products to products of other brands. All the necessary informations are available on official 2QT Cosmetics website.

12. Business Partner commits himself to avoid any action which could create financial or any other damage to trademark 2QT Cosmetics, to any Business Partner of 2QT Cosmetics Club or to any consumer of 2QT Cosmetics products. Business Partner commits himself to avoid any action which could lead to misuse of personal and contact data of other Business Partner of 2QT Cosmetics Club or to misuse of business information and know-how acquired during cooperation with 2QT Cosmetics , and that not only during active membership, but also in case of pausing or cancelling of 2QT Cosmetics Club Membership. Otherwise 2QT Cosmetics has the right to enforce by a legal action the covering of damages which have arisen.

13. Business Partner 2QT Cosmetics is obliged to an exclusive collaboration with 2QT Cosmetics. Business Partner can not collaborate with other competitors companies. 2QT Cosmetics has the right to cancel the 2QT Cosmetics Club Membership to the member who violated this close.

14. Business Partner has to ask 2QT Cosmetics for approval for individual publishing or individual promotion containing any logo 2QT Cosmetics or any phrase containing the trademark 2QT Cosmetics, alternatively for any official photo or for graphics 2QT Cosmetics. The member is not allowed to make any modification to the image of 2QT Cosmetics products or to any of the official 2QT Cosmetics materials.

15. Business Partner is obliged to watch out for any potential changes in official informative materials in the General conditions of 2QT Cosmetics Club Membership, in related conditions and rules, which will be published on the official 2QT Cosmetics website.

16. Changes in the General conditions of 2QT Cosmetics Club Membership, related conditions and rules are valid and effective the day that they have been sent or published on the official 2QT Cosmetics website.

17. In case of violation of any article in the General conditions of 2QT Cosmetics Club Membership, 2QT Cosmetics has the right to interrupt the membership to Business Partner or an adequate deadline will be defined for rectification.

18. 2QT Cosmetics Club Membership is hereditary. The Membership is transferable to 3rd party who is not a member of 2QT Cosmetics Club but this only with a written approval of 2QT Cosmetics and under condition of fulfillment of relevant laws in the given country. The 2QT Cosmetics member code is hereditary by testament or written will. 2QT Cosmetics recommends to draw upon legal advice and to adopt precautions in order to be sure that the 2QT Cosmetics member code can be inherited by his descendants of its choice. The heirs or the person of its choice, will assume all the responsibilities of who inherited to them the activity, including commissions and/or payments according to the official 2QT Cosmetics Marketing Plan, including also the rights of who inherited the activity.

If a member dies without leaving any testament or written will, than for the transfer of 2QT Cosmetics member code will be applied the succession laws.

19. The Membership comes to an end (a) if the registered Member has never placed any personal order - purchase of products with 2QT Cosmetics points and does not do so for a period of 60 calendar days from the time of registration, will then receive an email notification that will inform the 2QT Cosmetics Member who will have 7 calendar days to make an order of minimum 30 points to keep his account active. If, at the end of the 7 days, this order is not placed, we will consider it as a confirmation of the inactivity of the account and it will therefore be canceled. (b) if the Member has not made a personal order - purchase of products with 2QT Cosmetics points for a period of 6 calendar months, it will be considered inactive, will then receive an email notification that will inform the 2QT Cosmetics Member who will have 30 calendar days to make an order of minimum 30 points to keep his account active. If, at the end of the 30 days, this order is not placed, we will consider it as a confirmation of the inactivity of the account and will therefore be canceled, (c) by agreement between 2QT Cosmetics and Business Partner, (d) by unilateral termination of Membership by any involved party. Unilateral termination by 2QT Cosmetics can take place only because of violation of the General conditions of 2QT Cosmetics Club Membership, alternatively because of non-rectification before defined deadline in case of interruption of the membership in 2QT Cosmetics Club. The appeal for rectification or the termination notice of the membership is effective in the moment of electronic delivery on Member's email address which was initially used for registration or was updated on the official 2QT Cosmetics website or in to the 2QT Cosmetics mailbox, both accessible after Business Partner's login on 2QT Cosmetics official website. In case Business Partner decides to terminate the collaboration with 2QT Cosmetics, and he requires the cancellation of his 2QT Cosmetics Membership, for the following six months and without the approval of 2QT Cosmetics, Business Partner will not be allowed to rejoin 2QT Cosmetics Member Club,

20. Invalidity or ineffectiveness of any article does not establish an invalidity or an ineffectiveness of other articles in the General conditions of 2QT Cosmetics Club Membership. Law applicable to purposes of membership in 2QT Cosmetics Club is the law of ITALY. What is not governed by the General conditions of 2QT Cosmetics Club Membership, by related conditions or rules, shall be governed by the Civil Code, D.Lgs 206/2005 and L. 173/2005 as amended and the applicable court is the Municipal Court of Bologna, Italy.
